Additional Note: Encumbrances from 2020 to be paid in 2021 were a total of \$275,297.91. This amount was reduced by liquidating three of the Encumbrances amounting to \$81,318.23. The work for the three encumbrances was never completed. Therefore the Encumbrance amount reported under the Solid Waste District Fund was \$193,979.68.

Additionally, regarding expenses and cost per capita. 2021 was a Cell Construction Year at our Landfill.
